India's ongoing growth trajectory entails massive industrial and infrastructural expansion, underpinned by large-scale construction activity. Apart from meeting critical developmental needs of a rapidly urbanizing society, this growth also promises to unlock economic opportunities for the country's huge workforce. However, in a business as usual scenario, such growth can exacerbate environmental risks, most notably air pollution and its cascade impacts on health and quality of life.

Recent years have seen concerted efforts by all stakeholders to reinforce policy and solution frameworks through which air pollution can be mitigated. Building on this, there is now need to pursue convergent action towards impactful solutions for clean air, and ultimately enable an industry-wide transition towards clean air oriented practices.
